WHAT IS PETERBOROUGH FOODBANK?

Today in Peterborough there are families and individuals struggling to put food on the table. For people on low incomes, a sudden crisis - redundancy, benefit delay or even an unexpected bill - can mean going hungry. Every day parents skip meals to feed their children and people are forced to choose between paying the rent and eating.

Peterborough Foodbank provides emergency food and support to local people in crisis.



Since opening in late 2012 we have fed over 7,000 adults and 3,500 children. We have given out over 100 tonnes of donated food.
